



UNDERTAKING

I, Amit Kumar S/o Sh. Nar Singh R/o VPO: Kheri Saoh and Manager Secretary of Sidon Great Mirds Federation hereby solemnly affirm and declare as under:-

- 1- That the grant for recognition is class not extendable and does not in any way imply any obligation to recognize/affidavit beyond class VIII.
- 2- That the school shall by the provisions of Right of Children to Free and compulsory Education Act, 2009 and the Haryana State Right of Children to Fee and Compulsory Education Rules, 2011.
- 3- That the school shall ensure that:-
 - (i) That school shall admit in class I, to the extent 25% of the strength of the class. Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion:
 - (ii) That school shall admit in class 2nd to 8th under rule 134-A to the extent of 10% of the strength of the class for meritorious students belonging to economically weaker section.
- 4- That for the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.
- 5- That school shall not collect any caption fee and subject the child or his or her parents or guardians to any searching procedure.
- 6- That the school shall not deny admission to any child for lack of age proof If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any of them.
- 7- That the school shall ensure that:-
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school,
 - (ii) No child shall be subjected to physical punishment or mental harassment,
 - (iii) No child is required to pass any board examination till the completion of elementary education,
 - (iv) Every child completing elementary education shall be awarded a certificate as laid down under rule 22,
 - (v) Inclusion of students with disabilities/special needs as per provision of the act,
 - (vi) The teachers are recruited with minimum qualifications as laid under section 23(1) of the act provide further that the current teachers, who at the commencement of this act do not posses minimum qualifications shall acquire such minimum qualification within a period of 5 years,
 - (vii) The teacher performs its duties specified under section 24(1) of the act, and
 - (viii) The teachers shall not engage himself or herself for private teaching activities.
- 8- That the school shall follow the syllabus on the basis of curriculum laid down by academic authority.



- 9- The school shall enroll students proportionate to the facilities available in the school as prescribed 19.
10- That the school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-
(ix) Area of school campus total built up area.
(x) Area of play ground
(xi) Room for Headmaster-cum-office-cum-Storeroom.
(xii) Number of Class rooms.
(xiii) Separate toilet for boys and girls.
(xiv) Drinking Water Facility
(xv) Kitchen for cooking Mid Day Meal
(xvi) Barrier free Access
(xvii) Availability of Teaching Learning Material/Play Sports Equipments/Library.

- 11- That no unrecognized classes shall run within the premises of the school or outside in the same of school.
12- That the school buildings or other structures of the grounds are used only for the purposes education and skill development.
13- That the school is run by a society registered under the Societies Registration Act, 1860 (21) of 1860) or a public trust constituted under any law for the time being in force.
14- That the school should be audited and certified by a Chartered Accountant and proper accounts statements should be sent to the District Elementary Education Officers every year.
15- That the recognition code Number allotted to your school is _____. This may please noted and quoted for any correspondence with this office.
16- That the school furnishes such reports and information as may be required by the Director of Education/District Elementary Education officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfilment of the condition or recognition or the deficiencies in working of the school.
17- That the Renewal of Registration of Society, if any be ensured.

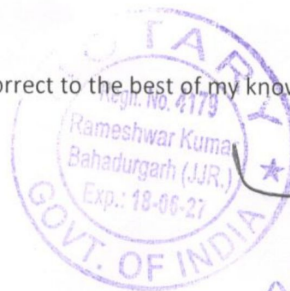
- 1- That the school building is safe, property ventilated, spacious and dimension of the class rooms & building is as per Haryana School Education Rules, 2003.


